WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act. 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- AND WHEREAS, the institution i.e. The Ankur B.Ed. College, Bagarwada, Behind CEO office, Minder Mandal, Nathdwara, Rajasthan has been recognized for B.Ed. by NRC vide order No. F.NRC/NCTE/ RJ-1138/2008/58415 dated 23.08.2008 for an annual intake of 100.
- 3, AND WHEREAS, the institution The Ankur B.Ed. College, Bagarwada, Behind CEO office, Minder Mandal, Nathdwara, Rajasthan has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed., which require additional facilities.
- AND WHEREAS, it has been decided to permit the institution two basic units of 50 students each 4. subject to fulfillment of the following conditions namely.
- The institution shall create additional facilities which include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adherence to staff norms as per Regulations, 2014 and inform the Regional Committees with required documents by October 31, 2015.
- The applicant Institution, for additional unit will be required to submit the required documents. (ii) such as fand documents, Non-Encumbrance Certificate (NEC), Land Use Certificate (CLU) and the Building Plan (BP) in the format available on the website, to the Regional Committee in proof of having provided additional facilities, before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents, if available, otherwise it may be given to the Visiting Team at the time of inspection.
- (iii) . The Regional Committee shall arrange for verification of documents, inspection of the premises and check adherence to these conditions by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending. such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.
- Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order The Ankur B.Ed. College, Bagarwada, Behind CEO office, Minder Mandal, Nathdwara, Rajasthan for conducting B.Ed. programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein, before 31.10.2015.

The institution shall be free to post additional relevant information, if is so desires.

Any false or incomplete information on website shall render the institution liable for withdrawal of recognition:

WHEREAS In terms of Section 14(1) The Ankur B.Ed. College, Bagarwada, Behind CEO Office, Minder Mandal, Nathdwara, Rajasthan has submitted an application (code No. 04032)the Northern Regional Committee of NCTE for grant of recognition/permission for starting B.Ed. of one year duration with an annual intake of 100 (One Hundred only) students on 23.02.2007.

- AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the secondary teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.
- NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) 3. of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to The Ankur B.Ed. College, Bagarwada, Behind CEO Office, Minder Mandal, Nathdwara, Rajasthan for conducting B.Ed. Course of secondary (level) of one year duration with an annual intake of 100 (One Hundred Only) students from the academic session 2008-09 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following:
  - The institution shall, within one month of the receipt of recognition order, (i) convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee. The institution shall comply with the various other norms and standards

(ii) prescribed in the NCTE regulations, as amended from time to time.

The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 (iii) notified on 10-12-2007.
